As part of the Life project "APPRICOD" (Assessing the Potential for Plastic Recycling in the Construction and Demolition Activities), funded by the European Commission, ACR+, IBGE-BIM and all the project partners are holding a European Workshop on 24 April 2006 in Brussels entitled:

## "Towards Sustainable Plastic Construction and Demolition Waste Management in Europe"

### A growing focus on plastic C&D waste

Construction and demolition (C&D) waste represent one of the largest waste streams, in quantitative terms, within the European Union. They are estimated to account for 180 million tonnes of waste per year.

In some EU countries, high recycling rates have been reached for the inert waste, which is the main fraction of C&D waste. But recycling for the other C&D waste fractions and in particular for plastic waste remains poor. At the same time, plastic use in the construction sector has increased in recent decades and this raises the question of how plastic should be managed when it becomes a waste.

### Based on concrete experiences, the Workshop will tackle issues such as

- How to optimise the selective collection of plastics from C&D waste? What are the different plastics involved and how can they be recognized, what are the requirements for plastic recycling, which plastic fractions can be collected together?

- What are the recycling opportunities and constraints?
- What costs and benefits are associated with a selective collection system for plastic C&D waste? Is it worth it?
- What are the opinions and perspectives from the main stakeholders: C&D sector, Plastic industry, Recyclers, Local and Regional Authorities, etc?
- What conclusions and recommendations can be made for the future?
- What are the legal, technical and financial needs?
- How can the plastic C&D waste issue be integrated into a broader resource-product-waste approach?

### The workshop is primarily intended for

- Construction and demolition actors (federations, construction companies, researchers, etc.)
- Public managers, especially from local and regional authorities
- The plastics industry (federations, companies, researchers, etc.)
- Academics

At this occasion, a Guide on the Sustainable Management of Plastic in C&D Waste will also be presented.

## More information on Life Project "APPRICOD"

The project is coordinated by IBGE-BIM. The APPRICOD Consortium is composed of 3 main groups of stakeholders concerned with plastic C&D waste management:

- The C&D sector (Belgian Building Research Institute, Brussels Confederation of Construction, European Demolition Association)
- The LA/RA authorities (Catalonia-ARC, Brussels Capital Region-IBGE-BIM, Provincia of Ancona, region of greater Porto-LIPOR, Association of Cities and Regions for Recycling and for sustainable Resource management - ACR+)
- The European plastics industry and recyclers: APME (Association of Plastics Manufacturers in Europe), ECVM (European Council of Vinyl Manufacturers), EuPC (European Plastics Converters), EuPR (European Plastics Recyclers)
