



ACR+ Activity Report 2008 (DRAFT)

Approved at the General Assembly in San Sebastian on 19 April 2007 and updated by the Board of Directors on 20 September 2007, ACR+'s work programme has been faithful to the Association's founding philosophy:

- promote waste management that respects a five-level hierarchy (reduction at source, reuse, recycle, energy recovery, careful elimination)
- integrated approach to the "resources-products-waste" problem
- multi-instrument activities (legal, economic, educational/communicational).

The 2008 work programme was set out according to 3 main working themes:

1) Influence European politics on waste and resources: 2008 has been an important year at European level, namely with the final approval of the new Waste Framework Directive and the beginning of the revision process of the WEEE directive.

ACR+ has provided its members with constant information along the adoption process and the debates in the EU institutions concerning the Waste Framework Directive.

2) Acting for prevention, with a large number of activities under the umbrella of the European Campaign for Waste Reduction "-kg", namely:

- the cluster "biowaste" met under Presidency of Lipor and as a result a report has been elaborated. This report focus on the prevention potential, the performance indicators for the main prevention actions and a first set of recommendations.
- dedicated section of ACR+ website with news and technical information
- the organization of a pilot edition of the future European Week for Waste Reduction from 22 until 30 November 2008
- the elaboration and submission of a Life+ project proposal with Ademe end 2007 about the creation and promotion of a European Waste Reduction Week. This project has been officially approved in November 2008
- the preparation of new projects with certain members in the framework of the Life+ and Interreg IVC calls for projects (see below and WP 2009).



3) Helping local and regional authorities attain sustainable waste-product-resource management, ACR+ will continue to propose its members to develop their technical expertise through:

- the organization of international conferences or working groups gathering the best European experts
- the publication of new technical reports on topical issues
- the set-up of EC funded projects and European partnership proposals for its members
- the weekly Newline service, the Warmer Bulletin, the ACR+ specialised website www.acrplus.org and a new bi-monthly electronic information letter on ACR+ activities and European waste policy news (ACR+ update).

ACR+ Activities in 2008 in a Nutshell

The content of a reference book on municipal waste in Europe was elaborated during 2008 (will be published in 2009, see WP 2009)



3) ACR+ Working Groups

WEEE-PIN (chair: Interafval-BE and AMORCE-FR): this working group met on 26 March 2008 and participated in the Stakeholders consultation concerning the revision of the WEEE Directive and organized by the European Commission. The WEEE-PIN issued an Opinion paper and various press releases.

4) European Projects

ACR+ prepared or participated in the preparation of various project proposals in answer to European calls, namely on:

- the creation of a Euro-Mediterranean network on waste management and sustainable consumption (ANEAL call DG Aidco, not selected)
- implementing and assessing waste prevention actions at local level (coordinated by Rennes-Métropole, FR, in process of being submitted under Life+ call)
- organic waste sustainable management (coordinated by Vlaco-OVAM, BE, to be submitted in January 2009 under Interreg IVC call)

As a complement, preparatory discussions have taken place concerning the following projects (see also WP 2009):

- consumers information and sustainable distribution
- resource recovery
- smart lifestyles
- evaluation and perspectives regarding Extended Producer Responsibility

5) Members

In November 2008, ACR+ had 91 members (69 local and regional authorities, 8 networks or syndicates of municipalities, 10 NGOs, 2 academic/scientific establishment and 2 private sector partners).

Since the previous ACR+ General Assembly, the Association has welcomed into membership:

- Alessandria (IT), Belfast City (UK), Budapest (HU), Cranfield University (UK), CRIOC (Belgian Consumers Association, BE), Dun Laoghaire (IE), EPA (IE), Fundació Catalana per a la Prevenció dels Residus i el Consum Responsable (ES), Malta (MT), NVRD (Dutch Association of public waste managers, NL), Rudologia (FR), Finnish Solid Waste Association (FI), ORDIF (Regional Observatory for waste of Ile de France)

We have registered 5 resignations:

- Doncaster (UK), Shanks (UK), Lons-Le-Saunier (FR), ENVAC (SE), EPA (IE)



During the same period, the Region of Castilla La Mancha (ES), London Community Recycling Network (UK), Valles Oriental (ES), North London Waste Authority (UK) and Sitom 93 (FR) have also undertaken steps to become ACR+ members.
