HIGHLIGHTS



The More Circularity, Less Carbon campaign publishes the results of its second cohort which involves Ireland, the region of Navarra (ES), and the city of Odense (DK). The cross-analysis of the results show that, just as for cohort 1, textile, food, and plastic are the most carbon-intensive fractions for all three territories. Reaching the -25% target for them would require reducing two key target fractions by 30 to 40%, which calls for much more ambitious prevention targets and strategies.




The report "Quantified actions to prevent household food waste" presents practices and strategies for which food waste reduction was monitored and documented, and suggest recommendations on how local and regional authorities can promote household food waste reduction practices.

Following its launch the Circular Cities and Regions Initiative offers the possibility of being involved as Pilot or Fellow to benefit from increased support, collaboration and knowledge sharing regarding circular economy solutions at local and regional levels



We discuss the pathways to a circular resilient Europe during the General Assembly 2022 and invite ACR+ members to move away from the traditional definition of a model of production and consumption aiming to keep materials and products as long as possible and to take into consideration all aspects of sustainability when talking about circular economy, especially the cultural one.





ACCESS increases sport organisations' capacities and knowledge on environmental matters, improving their governance patterns and making sport events more sustainable.

CISUTAC aims to increase the circularity of textiles and minimise the sector's total environmental impact by developing sustainable, novel, and inclusive large-scale European value chains.

Prepsoil supports the implementation of the EU Mission A Soil Deal for Europe by creating widespread awareness and fostering knowledge sharing on soil needs' identification in 19 European pedo-climatic regions.

BIOTRANSFORMS provides European policymakers with an adequate assessment and policy development framework, knowledge base and an expert support ecosystem for the transition to a circular bioeconomy.

DECISO supports European cities and regions to develop financing schemes for circular economy initiatives, learning from four pilots covering the sectors of water, waste, energy, and agrifood.

FER-Play is a comprehensive approach to gather, harmonise, complement, and diffuse the knowledge on alternative fertiliser value chains to promote the wide-scale production and application of alternative fertilisers.

H4C Europe and H4C Ecop are creating a community of practice, a knowledge platform, and exchange structures to help existing and future Hubs for Circularity (H4C) to overcome barriers to the implementation of industrial symbiosis, industrial-urban symbiosis and circularity.


OREN involves rural entrepreneurs in an interactive multi-stakeholder learning platform to train the participants in advanced managerial and business skills.


