EVENT'S PURPOSE

The revised waste proposals (COM(2015) 614 final) from 15 December 2015 include increased recycling targets for packaging materials, including plastic packaging waste, which will reinforce the targets on municipal waste and improve the management of packaging waste in the commercial and industrial sectors. The European Commission will also give a specific focus to plastic in particular with a follow-up of the 2013 Green Paper on plastics and measures to foster high-quality recycling of plastic material. The recycling rate of plastic packaging waste in Belgium is about 40% (Eurostat).

This event is organised by [ACR+](#) in the framework of the [PPI4Waste project](#) and aims to give the opportunity of a dialogue between Belgian public procurers and suppliers in the field of plastic waste management. The objective is to improve the market knowledge of contracting authorities and the suppliers understanding of public needs.
