# Apply for a peer-review

#### **Pre-conditions:**

- Policy responsibility of the host (local/regional authority, managing authority)
- Readiness to lead and coordinate the process
- Registered member of the Interreg Europe community: <a href="https://www.interregeurope.eu/account/registration/">https://www.interregeurope.eu/account/registration/</a>

#### **Selection criteria:**

- the policy area addressed (thematic relevance for the programme: resource efficiency, waste management, circular economy, eco-innovation... and all "Thematic Objective 6" topics)
- the strong motivation of the candidate for a peer review
- the involvement of relevant local and regional stakeholders (if relevant for the addressed policy area)
- the potential for policy impact and follow-up action
- the clarity, completeness and overall quality of the proposal

# Step by step



### An indicative agenda for the process

#### First briefing by the thematic expert and finalisation of the host region's demand:

 Info about the selection – appointment of an overall coordinator at the host region – first briefing by the thematic expert (phone/ online) – preparation of a thematic background paper by the host region

#### Peer selection and preparatory works for the onsite peer review:

 Identification of potential peers by the thematic expert – notification of the selected peers – joint online meeting between the host, the selected peers and the thematic expert – preparation of input for the visit

#### Onsite peer review – two full working days:

Pre-meeting of peers – joint plenary – meetings/ interviews with stakeholders (optional) – preparation of draft
 recommendations – joint peer review session – final conclusions and preparation of "to do-list" for follow-up action

#### Follow-up process:

- Concise peer review report (including the developed "to do-list")
- Short evaluation survey
