## **The Environmental Implementation Review (EIR)**

- > a tool to improve implementation of EU environmental law and policy
- > a two-yearly cycle of analysis, dialogue and collaboration, with a set of country reports for each EU Member State
- The latest EIR set of country reports published in April 2019 <u>http://ec.europa.eu/environment/eir/ind</u> <u>ex\_en.htm</u>





## **TAIEX-EIR PEER 2 PEER**

- > A tool for peer-to-peer learning between environmental authorities of EU Member States
- > Objective: sharing experience and good practice in environmental implementation and governance
- > Using the Commission TAIEX programme
- Demand-driven: peer learning events are organised on request of Member States
- > Applications can come from local, regional or national level
- Commission is in the role of a facilitator
- > Quick and flexible
- Financing travel & accommodation and expert work



#### TAIEX-EIR PEER 2 PEER

A new tool bringing together environmental implementation policy experts



#### COM provides mechanisms to: facilitate exchanges between competent authorities and experts, organise study visits, workshops...

- <u>Taiex REGIO P2P</u>: exchange of expertise in managing ERDF structural funds) -on-going until 2020.
- <u>Taiex EIR P2P</u>: overall environmental implementation gaps

#### P2P: WaterFrameworkDir/FloodsDir plans –more specific technical gaps (e.g. economic analysis art. 9, pressures analysis 3<sup>rd</sup> cycle) launched end 2017, for 2 years.

#### EXPERT MISSIONS



EU Member State experts can be sent to institutions in other Member States that have requested peer advice and exchange experience on a specific topic. Expert missions can last between 2 to 5 days.

#### STUDY VISITS



Employees (maximum 3) from a requesting institution can be sent on a working visit to other EU Member State institutions to learn from peers and exchange good practices. Study visits can last between 2 to 5 days.

#### WORKSHOPS



Single or multi-country workshops can be organised in a requesting institution. Workshops would normally last 2 days.

**Greece with Italy, Portugal, Spain and Slovenia: Workshop for over 20 Greek municipalities with experts from Italian, Portuguese, Spanish and Slovenian cities and regions**, 12 – 13 June 2019

## **TAIEX-EIR P2P** - How does it work?

- > EIR PEER 2 PEER assistance is provided on request of a Member State public institution involved in the implementation of EU environmental policy and law
- Requests can be submitted by national, regional or local public bodies, as well as from regional or local environmental implementation businesses, entrusted with a public task (e.g. waste water treatment)

#### > Requests have to provide information on

- > Applicant, contact person
- > Objective
- > Justification
- > Expertise required
- Participants and target group
- ➤ Timing

### TAIEX-EIR PEER 2 PEER - What is financed?

- Participants in workshops: travel + accommodation (for participants from the hosting country only if minimum distance between venue and residence)
- Experts in expert missions or workshops: travel, accommodation, per diem
  + Flat Daily Allowance per working day
- Participants in study visits : travel + accommodation
- > 1 Flat Daily Allowance for the host of study visit
- > Working language English; interpretation can be paid, if duly justified
