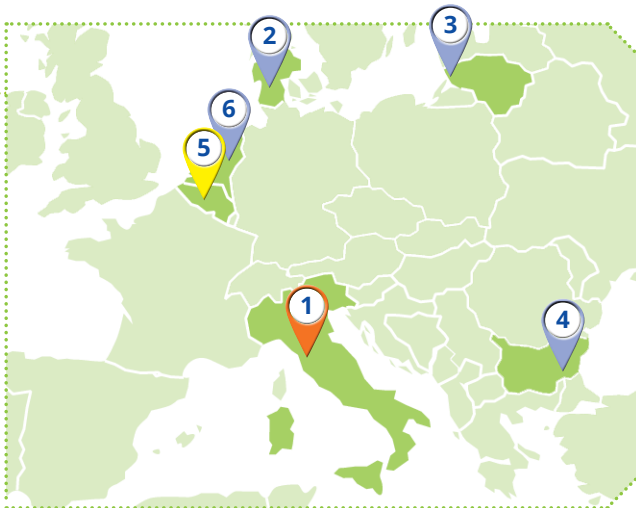

What is SMART WASTE all about?

Public authorities are striving to manage their waste in a comprehensive, sustainable, and circular way by considering **new approaches and technologies** to **reduce, reuse, recycle, and recover waste**.

But what are the results of their actions? Are these measures having a **concrete impact**? Could their implementation be more effective?

The Interreg Europe SMART WASTE project evaluates to what extent current local, regional, and national **environmental policies** of the SMART WASTE territories have promoted **successful innovation in waste management**. It then proposes interregional solutions to **address policy weaknesses**.

“The final result? Smarter, more effective, sustainable, and cost-efficient waste management, benefiting all territorial actors.”

One project, two phases

To ensure a successful and significant improvement of the policies targeted by the project, the SMART WASTE partners will work in two steps.

Evaluation (August 2019 - July 2022)

1. Share a common **evaluation methodology**;
2. Evaluate, in close collaboration with **local stakeholders**, innovation in waste management policies;
3. Identify **good practices and failures** to address;
4. Exchange and **match good practices** and failures.

Implementation (August 2022 - July 2023)

1. Design an **Action Plan** to tackle identified failures;
2. Develop **long-term recommendations** for future policies.

Where will SMART WASTE act?

Five territories are encompassed in the field of action of SMART WASTE.

With the help of an expert Advisory Partner, environmental policies will be tackled by the **five policy partners** in:

- the municipalities of Kolding (Denmark) and Apeldoorn (Netherlands);
- the region of Tuscany (Italy);
- the national territories of Bulgaria and Lithuania.

“SMART WASTE territories will see more waste prevention and increased reuse, recycling and recovery of waste, with knock-on environmental and economic benefits.”
